#### 6 (a) CCA - Fly Ins

In the spring of 2022, the Executive along with the ABP Board of Directors chose to host an event in Alberta and invite Alberta MPs to the function rather than traveling to Ottawa. It was felt that relationship building with Alberta federal MP's could be more productive in this setting where both CCA and ABP concerns could be raised in a more informal manner.

It was expanded to include Alberta MLA's. ABP funded the event but included representatives from ACFA, WSGA and the CCA. The function was deemed extremely successful with both MP's and MLA's providing suggestions on how to grow the event, encouraging another for 2023. This request for decision will formalize the event for ABP on an annual basis with funding replacing the fly-in to Ottawa. In the event of a situation that requires ABP's attendance in Ottawa, appropriate representatives will be sent to advocate on behalf of the Alberta producers utilizing the Trade Advocacy to fund.

 That Alberta Beef Producers Board of Directors formalizes the "Alberta Beef Industry Summit" as an annual event held in conjunction with the Calgary Stampede, replacing the Fly-Ins to Ottawa held each spring.
