Whereas: The intensity and destruction of wildlandurban interface fires in Alberta, and the costs of fighting such fires and rebuilding the communities is becoming unbearable. More effective, and cheaper, preventative methods are needed.

And whereas,

Creating large firebreaks around urban areas by removing coniferous fuel types is one of the most effective forms of Fire smarting a community, the costs of creating and maintaining this change in fuel type with manpower has been a barrier to adoption.

And whereas,

Cattle producers have been losing pastureland to development and cultivation, there is a potential solution to address both problems- using cattle to maintain an open, mixed grass-woodlot around communities, as is being piloted in British Columbia already.

Be it resolved: ABP lobby the Alberta Government to establish community pastures and grazing reserves in the green zone around forested communities to reduce fire risks to urban areas while also increasing available grazing land for cattle.

Open discussions were held by the board, and all were in agreement that this resolution would be better served if the resolution was sent to the RMA as it was not within ABP's mandate but ABP would support and encourage the RMA to investigate fire mitigation around the out skirts of towns and cities on the issue.
