# Monday December 4, 2017

## 1. Call to Order

Bob Lowe welcomed everyone to the AGM gave a brief update on some of the activities that have happened to in the beef industry over the past year.

Virgil Lowe, Business Manager VBP+, presented the pilot for the Beef Sustainability Accelerator. The purpose for the pilot in the short term is to learn how to deliver sustainable beef from the ranch to the grocery store. Cattle that move through a fully verified sustainable supply chain the producer will receive financial credits.
