4. ABP Plan Strategic Overview

Dubeau thanked everyone for being there and gave a general update on the operation of ABP over the past year and ABPs vision and mission statement has not changed.

Our Vision

"A strong and clear voice for cattle and beef producers contributing to a vigorous and profitable beef industry."

Our Misson

"To strengthen the sustainability and competitiveness of the beef industry for the benefit of beef producers in Alberta.

5. Canadian Cattle Association

Phinney spoke to the challenges facing the beef industry and steps that CCA is working with government officials on.

6. Staff Presentations

(a) Minister Sigurdson spoke to the challenges in the agricultural industry and that drought will affect all areas of the agricultural sectors and he will continue to advocate for the industry.

The provincial government is working on a drought emergency plan and have set up a drought advisory committee made up of agricultural and irrigation leaders, indigenous industry, and rural urban communities, they will be meeting regularly to debate and discuss long term solutions.

(b) Beef Production and Extension - Schmid

Schmid spoke to research being expensive, incremental, and long term and we do a lot of coordination with other beef industry funders.

Currently ABP has 41 active projects this included 5 that are currently approved but not contracted.

2024 Beef Research Showcase will be held Mar 11th, 2024 at Olds College.

(c) Government Relations and Policy - Lyseng

Lyseng spoke to the Agri Recovery – Canada-Alberta Drought Livestock Assistance and stated that qualifications were complex but attempted to not penalize producers for being prepared or being resourceful. Agri Recovery for 2023 will pay out \$165m and the first wave closed on January 15 and the second was closed February $22^{\rm nd}$.

Lyseng discussed the Business Risk Management (BRM) and stated that there are gaps with the current programs and a lack of consistency across sectors, pointedly, cow-calf and backgrounding sectors are getting little support whereas other commodities were guaranteed profit and reached out to Agricultural Finances Service Corporation for evaluating Business Risk Management programs for the cow-calf sector in Alberta.

(c) Marketing and Communications - Roberts

Roberts spoke to the new strategy and fresh looks for the ABP magazine, and the four distinctive themes and each theme spotlights a sector of the industry.

Roberts discussed the Consumer Campaign – ABP Solo Awareness Campaign and the strategy to separate the RAISE section from the consumer campaign and expand it to showcase "Our producer recipes to raising the best beef ever". Focus on the people, and the legacy behind what goes into producing iconic Alberta Beef.

(d) Stakeholder and Relations - Murphy

Muphy spoke to Communications, Environmental Stewardship Award and Youth Engagement.

In 2023 Alberta Beef producers combines the goals behind a Dedicated ABP Daily app and an accessible website and began focusing on a mobile -friendly website capable of being added to a users list of mobile apps.

The production of Beef and the environment are closely linked. Grazing cattle are an integral part of the grassland ecosystems and play an important role in the nutrients. Producers strive to manage and enhance environmental stewardship to the best of their abilities. Congratulations to Alberta Wray Ranch, recipients of The Environmental Stewardship Award (TESA) for 2023!

(e) VBP+ Coordinator and ABP Stewardship Lead - Segboer-Edge

Segboer-Edge spoke to the Advancing Priority Stewardship Issues

- 1) Predation Alberta's predation is managed by the Ministry of the Environment, multiple stake holders and are working to build an Alberta based solution.
- 2) Ungulates Whitetail, Mule Deer, Elk, and other ungulates are the focus of building on existing programs to better support producers.
- 3) Ecological Goods and Services relates to rangeland management. Work with Government and other stakeholders to advance opportunities to recognize producers for the ecological good and services they provide through the management of rangelands.
